Las energías renovables se han desarrollado rápidamente en Italia durante la última década y han proporcionado al país un medio de diversificarse de su dependencia histórica de los combustibles importados.

Los 8.047 municipios italianos han desplegado alguna fuente de energía renovable, siendo la energía hidroeléctrica la principal fuente de energía renovable en términos de producción. La bioenergía, la energía eólica y la geotérmica también contribuyen de forma importante a la demanda nacional de energía.

Italia ha puesto en marcha generosos programas de incentivos para fomentar el desarrollo de la producción de energías renovables. Su mayor plan incentivó la producción de energía solar fotovoltaica y llevó a Italia de una base baja de energía fotovoltaica instalada en 2010 a convertirse en el cuarto país del mundo por instalaciones a finales de 2014, por delante de EE.UU. en ese momento.

Todas las fuentes de energía renovable han crecido en Italia en los últimos años y muchas siguen recibiendo incentivos. En la última década, Italia se ha convertido en uno de los mayores productores mundiales de energía renovable, siendo el segundo productor de la Unión Europea y el noveno del mundo.
