El agua potable se produce con un sistema de filtración por ósmosis inversa (OI), un sistema de filtración que utiliza una membrana especial. También conocida como Membrana, que está hecha de fibras sintéticas de celulosa con una resolución de 0,0001 micras, que es más pequeña que un cabello. Con esta propiedad, hace que la solución de contaminantes como metales pesados, fertilizantes químicos, pesticidas, plomo y diversos patógenos que es más grande an no penetrar a través de esta membrana de filtro. Sólo las hebras puras pueden penetrar.

Los contaminantes atrapados en el medio filtrante se eliminan inmediatamente del sistema para evitar que se acumulen dentro de la unidad, separándolos del agua pura filtrada. Este método permite filtrar el agua por ósmosis inversa.
