Se vende una empresa inglesa rentable dedicada a los créditos de carbono. Un crédito de carbono es un certificado o permiso negociable que representa el derecho a emitir una cantidad determinada de dióxido de carbono o la cantidad equivalente de otro gas de efecto invernadero (tCO2e).

Los créditos de carbono y los mercados de carbono son un componente de los intentos nacionales e internacionales de mitigar el aumento de las concentraciones de gases de efecto invernadero (GEI). Un crédito de carbono equivale a una tonelada de dióxido de carbono o, en algunos mercados, a gases equivalentes de dióxido de carbono. El comercio de carbono es una aplicación de un enfoque de comercio de emisiones. Las emisiones de gases de efecto invernadero se limitan y luego se utilizan los mercados para asignar las emisiones entre el grupo de fuentes reguladas.

Hay dos tipos de créditos. La reducción voluntaria de emisiones (RVE) es una compensación de carbono que se intercambia en el mercado extrabursátil o voluntario por créditos. La reducción certificada de emisiones (RCE) se basa en unidades de emisión (o créditos) creadas mediante un marco regulador con el fin de compensar las emisiones de un proyecto.
