A la venta una empresa inglesa rentable que comercia con bonos de carbono. Un bono de carbono es un certificado o permiso negociable que representa el derecho a emitir una cantidad fija de dióxido de carbono o la cantidad equivalente de un gas de efecto invernadero diferente (tCO2e).

Los bonos de carbono y los mercados de carbono son un componente de los intentos nacionales e internacionales para mitigar el crecimiento de las concentraciones de gases de efecto invernadero (GEI). Un bono de carbono equivale a una tonelada de dióxido de carbono o, en algunos mercados, a gases equivalentes al dióxido de carbono. El comercio de carbono es una aplicación de un enfoque de comercio de emisiones. Las emisiones de gases de efecto invernadero se limitan y luego se utilizan los mercados para asignar las emisiones entre el grupo de fuentes reguladas.

Hay dos tipos de bonos. La reducción voluntaria de emisiones (VER) es una compensación de carbono que se intercambia en el mercado extrabursátil o voluntario por bonos. La reducción certificada de emisiones (CER) se basa en unidades de emisión (o bonos) creadas a través de un marco regulatorio con el propósito de compensar las emisiones de un proyecto.
