Central Hidroeléctrica de 10MW

Se trata de la venta de un permiso de construcción y un proyecto para la construcción de una Central Hidroeléctrica en Brasil. Esta Central Hidroeléctrica tiene una potencia instalada de 10M, está ubicada sobre el río Lava ludo, en los municipios de Sao Joaquim y Urupema, en el estado de Santa Catalina.

Puntos clave

- Potencia instalada= 10 MW
- Garantía Física (potencia firme)= 5,2 MW (Promedio)
- El motor consta de 3 Turbinas Francis Simples, con una altura bruta de 54,7 m.

Etapas

- El proyecto cumple con su diseño básico con DRS aprobado, estudio ambiental presentado para la obtención de la Licencia Ambiental Previa
- La conexión al sistema se realizará a través de una línea de transmisión de 34,5kV con una longitud de 15 km que conectará el bus de 138 kV de la SE Coletora de los desarrollos Lava ludo, que se construirá en consorcio con varias otras plantas
- Detalles Disposición General, Cronograma y Presupuesto El embalse tiene una superficie de 63 ha de superficie total
- La presa será de enrocado con núcleo de arcilla, de 211 m de longitud y 22 m de altura
- El aliviadero propuesto es del tipo canal lateral, de 100 m de longitud, con capacidad de diseño de 1450 m³/s.
- La aducción se realiza a través de un túnel de 2.487 m de longitud. El cronograma de implementación es de 18 meses
