

La empresa recoge, recicla y valoriza una amplia gama de residuos, como plásticos, metales férricos (acero) y no férricos (cobre, níquel, aluminio, etc.), proporcionando materias primas secundarias de alta calidad para la industria del plástico en forma de triturado o granulado a partir de diversos tipos de residuos plásticos. La empresa se centra en grandes e importantes generadores de residuos, ofreciendo productos y servicios de calidad superior y siendo un cliente y/o proveedor apreciado y respetado.

A lo largo del tiempo, la empresa ha tenido una evolución financiera, logística y comercial positiva año tras año, consiguiendo obtener beneficios anualmente, independientemente del contexto/entorno económico más o menos favorable. Actualmente se beneficia de una red de proveedores bien organizada, de un personal cualificado y bien formado, consiguiendo ser proveedor de algunas empresas europeas de renombre en el sector y tener una posición fuerte en el mercado de Rumanía y Europa. El espacio de producción es nuevo, moderno, está bien equipado y cuenta con todas las homologaciones necesarias para su buen funcionamiento. Consta de: una nave de producción sobre estructura ligera de unos 600 m², espacios de almacenamiento cubiertos de unos 1000 m², una instalación de energía eléctrica con transformador y red propia de unos 250 kW, plataformas de almacenamiento hormigonadas y pavimentadas de unos 5000 m², vallado perimetral y puerta de acceso, edificios de oficinas y otros espacios necesarios para la actividad.
