Los avellanos suelen plantarse en huertos y requieren podas y mantenimiento regulares para garantizar un crecimiento óptimo. Los árboles producen nueces a finales de verano y principios de otoño, que se recogen cuidadosamente a mano para no dañar las delicadas cáscaras.

Una vez recolectadas, las avellanas se secan y se procesan para quitarles la cáscara exterior. Este proceso se realiza con un equipo especializado que rompe las cáscaras sin dañar la nuez de su interior. A continuación, las nueces se clasifican por tamaño y calidad antes de envasarlas para la venta.
