La empresa figura entre las 15 primeras de Turquía, especializada en la producción de mineral de cromo y concentrado. Es una empresa familiar. Debido a sus favorables relaciones Cr/Fe y Mg/Al, el mineral de cromo de Turquía tiene una gran demanda, sobre todo por parte de China, el principal importador. Posee tres zonas autorizadas y explota dos instalaciones de enriquecimiento de cromo, con una plantilla de 150 empleados. Sus niveles de reserva están siendo verificados por DMT Group, una empresa consultora mundial.

Hasta ahora, la empresa sólo ha explorado el 2% de su zona autorizada. Para finales de 2023, se espera que la relación entre reservas y producción supere los 100 años, pudiendo establecerse una instalación de producción de ferrocromo, lo que permitirá fabricar un producto de mayor valor añadido.

Panorama del mercado

El mineral de cromo es un mineral vital utilizado principalmente en la producción de ferrocromo, un ingrediente esencial en la fabricación de acero inoxidable. La demanda mundial de acero inoxidable, impulsada por industrias como la construcción, la automoción y los bienes de consumo, influye significativamente en el mercado del mineral de cromo. A finales de 2023, la creciente atención a la construcción sostenible y la proliferación de vehículos eléctricos amplificarán aún más la demanda de acero inoxidable de alta calidad, impulsando así la utilización del mineral de cromo.
