    - 31,84% Azufre (S)

    - 0,4 – 1,25 g/t Oro (Au)
    - 30 – 225 g/t Plata (Ag)
  - Rico en materias primas críticas clasificadas por la UE, como cobalto (Co), indio (In), antimonio (Sb), bismuto (Bi) y arsénico (As).
- Estériles existentes con valor adicional:
  - 575.000 toneladas de estériles valiosos que contienen metales preciosos y no férricos valorados entre 50 y 100 millones de euros.
- Potencial de profundidad inexplorado:
  - No se han realizado exploraciones modernas, perforaciones con núcleo de diamante ni estudios geológicos avanzados.
  - Alta probabilidad de que existan reservas de mineral más profundas y sin explotar.
