Según las directrices de la FINMA en virtud de la Ley Federal Suiza de Instituciones Financieras (LEFin), una empresa que actúa como fideicomisaria se define como una entidad que gestiona o dispone profesionalmente de un fondo separado en beneficio de los beneficiarios o para un fin determinado.

Las actividades y responsabilidades clave de un fideicomisario autorizado por la FINMA incluyen:

- **Gestión de activos:** El fideicomisario gestiona y dispone de los activos del fideicomiso de acuerdo con los términos del fideicomiso y las obligaciones legales.
- **Deber fiduciario:** El fiduciario tiene el deber legal y fiduciario de actuar en interés de los beneficiarios.
- **Operaciones comerciales:** Se considera que una empresa es un fideicomisario comercial si genera más de 50.000 CHF al año o gestiona fondos fiduciarios superiores a 5 millones de CHF, entre otros criterios.
- **Requisitos organizativos:** La empresa debe tener una organización adecuada, que incluya una gestión de riesgos y unos controles internos adecuados, y su dirección efectiva debe estar en Suiza.
- **Cualificaciones profesionales:** Las personas responsables de la gestión y la administración deben tener las cualificaciones profesionales necesarias y una buena reputación.
