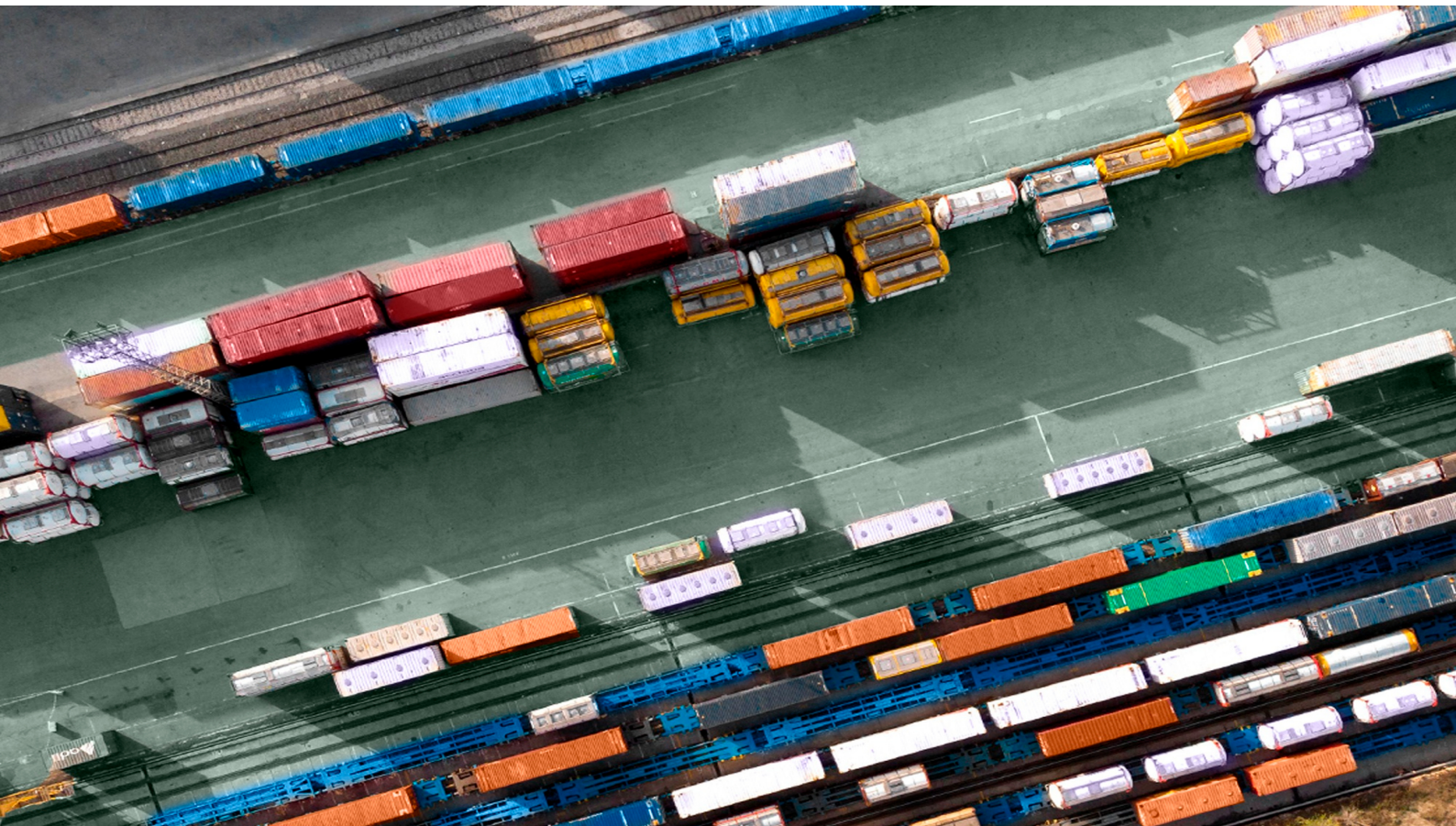

La instalación es adyacente a las terminales de almacenamiento de KazMunaiGas (10 depósitos de 25.000 tm de capacidad cada uno, disponibles para alquiler) y tiene acceso ferroviario directo al Consorcio del Oleoducto del Caspio (CPC), a Tengizchevroil (TCO), a la red ferroviaria rusa y al puerto del Mar Caspio.

La zona industrial de Atyrau sirve de corredor logístico clave entre los yacimientos petrolíferos occidentales de Kazajstán y los canales internacionales de exportación.

La proximidad a los principales operadores nacionales garantiza volúmenes estables, tramos de transporte minimizados y una eficacia competitiva en los plazos de entrega.

- Activos materiales: polígono industrial de 15 ha, instalaciones ferroviarias y vías;
- Contratos de arrendamiento a largo plazo con 2 empresas comerciales hasta 2031. Se pueden negociar pagos de alquiler de USD a trueque (gasóleo, azufre, etc.) a muy buen precio por lote. Memorando de Entendimiento con las empresas Tengizchevroil y KazMunaiGas;
- Acceso directo a CPC, al puerto marítimo del Caspio, a la red ferroviaria rusa, a Tengizchevroil y a KazMunaiGas;
