## Mina de oro operativa en exploración

Kirguistán posee muchas de las mayores minas de oro de Asia Central.

Situada en la vertiente septentrional de la cordillera de Kirguizistán, en la parte superior, componentes derechos del arroyo Karabulak, en la parte central de los yacimientos de Bulakashinsky.

Las rocas volcánicas intervienen en la estructura geológica del lugar. rocas representadas por andesitas y andesita-basaltos, sus tobas y clastolavas. Las rocas intrusivas están representadas por gabro-shonkinitas, sienita-dioritas y granodioritas, que son fases separadas de un único complejo intrusivo. Un rasgo característico de las formaciones de este complejo es su aspecto laminar, suavemente inclinado con ángulos de buzamiento de 10 o a 50 o , en las rocas volcánico-sedimentarias que las rodean.

Con estas estructuras y asociadas a la formación de zonas mineralizadas y cuerpos mineralizados del yacimiento.

La mineralización de oro y cobre identificada, así como las zonas de beresitización y silicificación en el yacimiento de Severny, están confinadas directamente a intrusiones de granodiorita o, más a menudo, a sus contactos intrusivos con rocas volcanogénicas e intrusivas anfitrionas.

La beresitización de la anchura de la zona alcanza aquí las primeras decenas de metros. longitud trazada a 400 m. Entre las beresitas, el veteado más intenso silicificación, portadora de diseminación diseminada de sulfuros de cobre, plomo, hierro, molibdeno.

### Puntos clave

El yacimiento de oro es en realidad un gran yacimiento formado por varios yacimientos de oro y 1 de cobre. El vendedor afirma tener una alta ley de oro (porcentaje de contenido de oro por 1 tonelada). Sin embargo, el campo no está bien desarrollado. Todos los datos son recogidos por ingenieros soviéticos y parece que no se ha hecho nada desde entonces.
