Este club de fútbol italiano a la venta en la Serie D "LEGA Nazionale Dilettanti" es un club conocido con sede en el sur de Italia. A lo largo de su historia, el club ha jugado muchas veces en los campeonatos de la Serie C, el club tiene un gran estadio disponible con parques.

El Serie D es el nivel superior de la Asociación de Fútbol no profesional italiana llamada LEGA Nazionale Dilettanti. La asociación representa a más de 12,000 jugadores de fútbol y 400 equipos de fútbol en Italia. La Serie D se ubica justo por debajo de la Serie C (la tercera y última liga profesional desde 2014-15), y por lo tanto se considera la liga del cuarto clasificado en el país. Está organizado por el Comitato Romano Interregionale (Comité Interregional), una "liga en la liga" dentro del LND.

Estructura

Desde principios de la década de 1990, la Serie D ha consistido en 162 equipos divididos en 9 divisiones regionales (GIRONI), generalmente formadas por 18 equipos cada uno, divididos geográficamente.

Para la temporada 2012-13, hubo 166 equipos. Se formaron dos grupos (B y C) de 20 equipos. En la temporada 2013-14, el número fue de 161 y un grupo (H) comprendió 17 equipos. Para 2014-15, la distribución por región fue la siguiente:

- Girone A - equipos de Aosta Valley, Piedmont, Liguria y Lombardy
- Girone B - equipos de Lombardy y Veneto
- Girone C-Equipos de Friuli-Venezia Giulia, Trentino-Alto Adige/Südtirol y Veneto
- Girone D-equipos de Emilia-Romagna, Toscana y Veneto
- Girone E - equipos de Lazio, Toscana y Umbria
- Girone F - equipos de Abruzzo, Lazio, Marche y Molise
- Girone G - equipos de Lazio y Sardinia
- Girone H - Equipos de Apulia, Basilicata y Campania
- Girone I - equipos de Calabria, Campania y Sicilia

Promoción

El primer equipo de cada división se promueve a la Serie C cada año, reemplazando a 9 equipos de LEGA Pro relegado a la Serie D.

Si un equipo de la Serie D recién promocionado no cumple con los requisitos, LEGA Pro pregunta al equipo de segundo lugar en la división del equipo de la Serie D para llenar la vacante. De lo contrario, el equipo del tercer lugar puede llenar la vacante, y así sucesivamente.
