– Durante su cotización en la Bolsa de Chittagong, la empresa siempre ha ocupado el primer o el segundo puesto en términos de volumen de negocios.

– La facturación prevista de la empresa se triplicará respecto a la actual con la introducción de la negociación en la Bolsa de Dhaka y los derivados.

– La empresa tiene varios modelos de ingresos, como las comisiones que cobra por la compra y venta de materias primas, las comisiones de mantenimiento, las comisiones de OPV y los cargos por servicios.

– Se trata de una empresa familiar con el 100% de la propiedad en manos de la familia.
