En 1990 diseñando la primera caja de herramientas con la marca registrada. La compañía ha comenzado el período de convertirse en fabricante de equipos de almacenamiento de plástico. El diseño y la marca fueron una novedad para el mercado nacional en ese momento.

Con este comienzo, que ha causado una reacción muy atractiva. La empresa aumentó rápidamente la gama de productos y comenzó las exportaciones en 1993.

En 2004, la empresa se mudó a la planta actual y continúa con el objetivo de lograr calidad en los productos y servicios en todo el mundo.

La empresa tiene la visión de estar equipada con las fuentes necesarias para una mejor calidad y servicio.

Desde mayo de 2002 el sistema está certificado por AQA American Quality Accessories bajo ISO9001:2000.

La fábrica está ubicada en una planta total de 10.000 m2. De los cuales 8.000 m2 son el área cerrada de fabricación. Que está equipada con máquinas de procesamiento e inyección de plástico de alta calidad totalmente automáticas.
